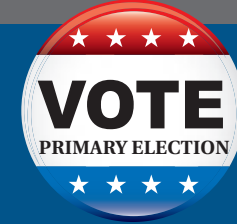

Every registered voter in Palm Beach is eligible to vote on the August 26 primary ballot. That's a change from the days when primary elections were strictly closed elections for Republicans and Democrats to select their candidates for a November general election. This election cycle, Democrats still have closed primary elections on the Primary Ballot for Governor and State Attorney General. Republicans have closed Primary Ballots for Congress and Governor.

All voters will vote for Circuit Court Judges and School Board. Winners (more than 50% of vote) in these races will go into office without having to compete in the General Election in November. Runoffs, if a candidate doesn't win more than 50% of the vote, are held during the General Election.



The Palm Beach Civic Association is a non-partisan organization that believes all civic-minded citizens will want to make informed decisions in the August 26 Primary. This Voters Guide details only the candidates on the Palm Beach ballot.

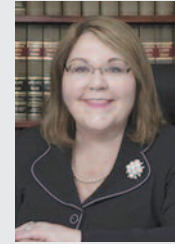

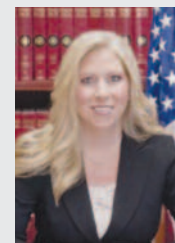
